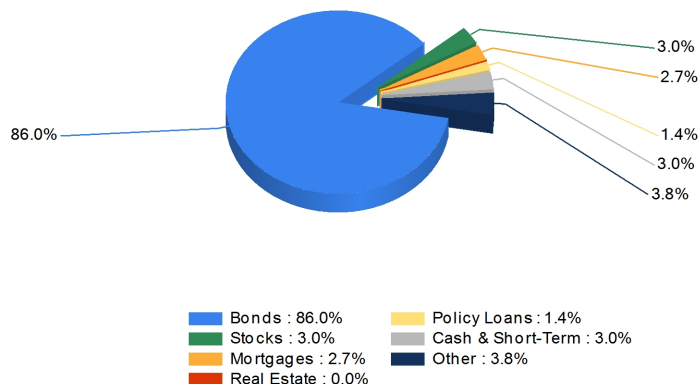

Invested Asset Distribution

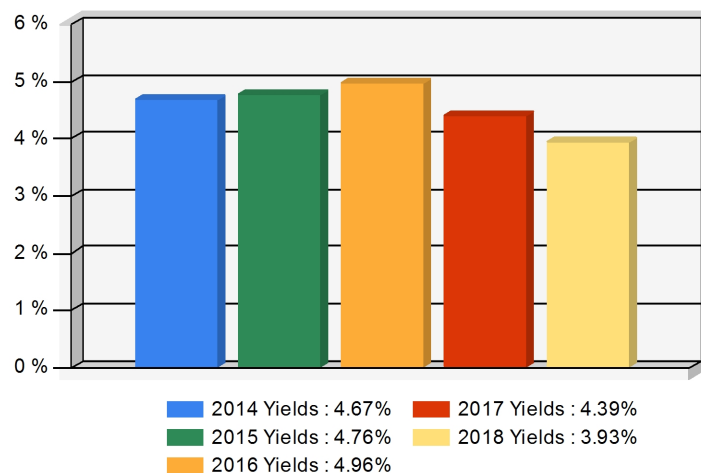

Distribution of the invested assets

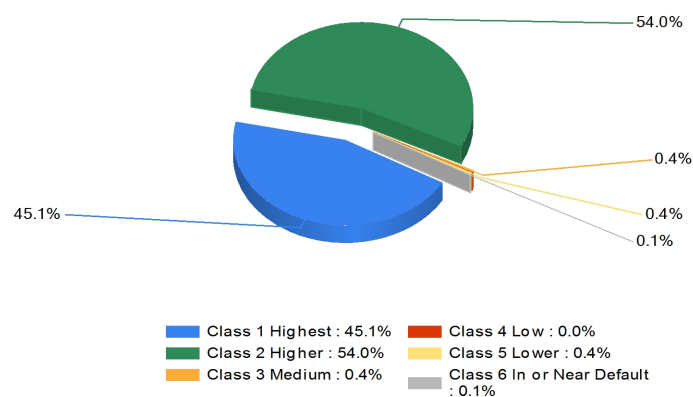


Net yield on mean invested assets
